## **13475 WATERTOWN PLANK ROAD**

The building is a multi-tenant retail center with 4 shops. It is located in a very visible high traffic location at the intersection of Watertown Plank and Elm Grove Roads, in the heart of the Village of Elm Grove. Other occupants include a cobbler, an art studio and a Chocolate Factory ice cream and sandwich shop. Sendiks Market, the Elm Grove post office, other restaurants, offices and many other retailers are located nearby.

# One store space is available at this time:

A 700 square foot storefront is available. This store space is about 26' wide by about 26' deep and has a private lavatory (see attached floor plan). Parking is available in front of this store. Electricity is separately metered.

#### <u>RENT</u>

The building is rented on a triple net basis with the tenant being responsible (on a proportionate basis) for the payment of real estate taxes, insurance, inside and outside maintenance, lawn care, snow removal, etc. The tenant's proportionate share of these expenses is payable monthly in addition to the base rent.

The landlord is responsible for all exterior maintenance.

Base Rent for this store is \$700.00 per month and adjusts yearly based upon the cost-ofliving index. The tenant's proportionate share of operating costs and taxes for 2016 is \$600.00 per month. **The total rent is \$1,300.00 per month.** 


A lease term of 2 to 5 years is preferred.

#### DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS

- 14 (e) The duty to protect your confidentiality. Unless the law requires it, the Firm and its Agents will not disclose your confidential information or the confidential information of other parties (see lines 23-41).
- 16 (f) The duty to safeguard trust funds and other property held by the Firm or its Agents.
- 17 (g) The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the advantages and disadvantages of the proposals.

23 **CONFIDENTIALITY NOTICE TO CUSTOMERS** The Firm and its Agents will keep confidential any information given to the 24 Firm or its Agents in confidence, or any information obtained by the Firm and its Agents that a reasonable person 25 would want to be kept confidential, unless the information must be disclosed by law or you authorize the Firm to 26 disclose particular information. The Firm and its Agents shall continue to keep the information confidential after the 27 Firm is no longer providing brokerage services to you.

#### 42 DEFINITION OF MATERIAL ADVERSE FACTS

A "Material Adverse Fact" is defined in Wis. Stat. § 452.01(5g) as an Adverse Fact that a party indicates is of such 44 significance, or that is generally recognized by a competent licensee as being of such significance to a reasonable 45 party, that it affects or would affect the party's decision to enter into a contract or agreement concerning a transaction 46 or affects or would affect the party's decision about the terms of such a contract or agreement.

An "Adverse Fact" is defined in Wis. Stat. § 452.01(1e) as a condition or occurrence that a competent licensee 48 generally recognizes will significantly and adversely affect the value of the property, significantly reduce the structural 49 integrity of improvements to real estate, or present a significant health risk to occupants of the property; or information 50 that indicates that a party to a transaction is not able to or does not intend to meet his or her obligations under a 51 contract or agreement made concerning the transaction.
